- 1. **The Government of Nepal (GoN)** has allocated funds to DDC for **Trail Bridge Sector Wide Program** and the DDC intends to apply part of the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Dovan Ghat Bridge, Patle Ghat, Tosha Ghat Bridge, short Span Trail Bridges (SSTB). Bid is open to all eligible Nepalese Bidders.
- The DDC Office, Baglung invites sealed bids from registered fabricators for supply of fabricated steel parts for following Short Span Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
- 3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for one steel truss motorable road bridge or one steel girder motorable road bridge or five trail bridges within last five years and enlisted by DoLIDAR are eligible for bidding. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLIDAR may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
- 4. Bidding documents may be purchased from the office of **District Development Committee**, **Baglung** by eligible Bidders, on submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table, until **2072/11/19** (*March 2, 2016*). For the purpose of Bidders who choose to submit their bid electronically through E-procurement section of PPMO's Web Site http://www. bolpatra.gov.np, may choose to down load the necessary part of bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. In case the Bidder chooses to download and submit bid electronically, the Bidder shall be required to deposit the cost of bidding document (as specified in the below table) in the DDC's **Rajaswa** (**revenue**) (**Ga 4 3 22 51 4910**) account either by direct deposit or by tele-transfer of deposit in the DDC account for the purchase the bids as specified below and electronic scanned copy (PDF format) of the Bank deposit voucher or Tele-transfer certificate shall also be submitted along with the electronic bid files.

- 6. Bids must be submitted to the office of **District Development Committee**, **Baglung**, on or before **12:00 hours(noon)** on **2072/11/20** (*March 3, 2016*). Alternatively, bidders may submit their bid electronically through E-procurement section of PPMO's Web Site http://www.bolpatra.gov.np as specified in the Instruction to Bidders. Documents received after deadline will not be accepted.
- 7. Bids will be opened physically and electronically in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2072/11/20 (*March 3, 2016*) at the office of **District Development Committee**, **Baglung**. Bids must be valid upto 2073/02/17 (*May 30, 2016*) and must be accompanied by bid security, amounting to a minimum of amount (inclusive of VAT) listed below, which shall be valid upto 2073/03/15 (*July 29, 2016*).
- 8. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit Account No. Ga 3 22 51 4693 of DDC Office, Baglung in Nepal Bank Limited, Baglung and submit bank deposit voucher along with the bid.

- 10.. If the last date of submission, opening and Pre-bid meeting falls on a government holiday then the next working day shall be considered as the last day.
